WHY DON'T YOU?

FIFTY PER CENT. ADDED.—All persons who failed to make their income returns on Monday, March 1st, are liable to be assessed by the Assessor, according to the best information he can obtain, and the law requires fifty per cent. to be added to the amount of tax. No appeal, from the valuation and enumeration, can be made. The law requires every person suspected of being liable to pay an income tax to make a sworn return, whether he has been supplied with a blank or not, notwithstanding the amount may fall short of \$1000 which is the amount exempted by law.

A TAX PAYER.

An Expensive Breakfast.
