Republican County Convention. The Republican County Convention met pursuant to a call of the Chairman of the County Committee, in the Court House, on Monday, July 10th.

After appointing N. M. Brookway, J. K. Whitmore, and D. C. Oyster, as Senatorial Conferees, and Jas. H. Hagerty, B. J. Buss, and Jerome Powell Representative Conferees, the Convention adjourned to meet at the call of the Chairman.

The California Democrats "departed," after the manner of the Ohio and Pennsylvania Programs, at their State Convention a day or two since. Aside from the "departure" resolution they passed another denouncing the poor Chinamen, thus showing that there was a large element of Bill Nye in the convention, mixed up with a little of Gov. Gearyism. They also renominated Governor Haight, and came down strong on railroad subsidies.—[Eric Republican.]

And so one fossil after another is brought to a knowledge of the truth.

No intelligent person can afford to be uninformed as to these events which have left so deep an impression on the world's history, and few will fail to read this splendid work, or, having read it, to endorse it as the Standard American History of the War.
