fee, sugar, rice, beans, soap and candles, and fresh beef. Wm. Morey

was designated as cook for Co H and in a short time breakfast was well under way, and the boys helping themselves to seats on the ground, with great relish stored away the government rations. The rest of the day was passed by the boys in getting straw for beds, cleaning guns, fixing up inside of tents, &c. In the afternoon we had dress parade, and at "taps" turned in for the night.

Thursday morning came cold and gloomy with the sun cloud-hid and a drizzling rain slowly wetting the clothes and chilling the spirits of the boys. All day the terrible drizzle kept up. Tents were overflowed, mud puddles formed in the streets of the company, while boots were covered with a thick mud.
