STATE OF SOUTH-CAROLINA
In the House of Representatives,
December 21st, 1793.

WHEREAS the Commissioners of pub-
lic accounts are required to deliver
to the House of Representatives, the
Treasury Accounts, respecting special In-
dents, without knowing the outstanding
amount thereof in circulation.—Therefore,

Resolved, That all holders of special In-
dents be directed, and required, on or before
the first day of November next, to deliver the
special Indents in their possession to one of
other of the Commissioners of the Treasury,
who are to give receipts for the same, and to
report to the Commissioners on public ac-
counts, on or before the tenth day of Novem-
ber next, the amount by them respective-
ly received, and also to the Legislature, at
their meeting in November next, and that
all special Indents not rendered into the
Treasury as above, on or before the first day
of November next, shall be, and the same
are hereby barred.

Resolved, That public notice of this resolu-
tion be given in the several Gazettes in this
State, once every three weeks, until the first
day of November next. And that the Dele-
gates of this State in the Congress of the Uni-
ted States, be requested to cause this resolu-
tion to be published in one or more papers
in the cities of Philadelphia and New-York,
and that provision will be made for the ex-
penses attending such publication.

the Senate for their concurrence.

Some few Counterfeit Post Notes of the
Bank of Maryland, having been lately dis-
covered in circulation, and on tracing the same
were found to come from the back parts of
Virginia, where they probably first issued; to
avoid imposition it is thought necessary to
give the following description of them, by
which they may readily be detected.

They have the letter D, for their alphanu-
merical mark, at the left hand side of the Note.

The paper on which they are printed is
more soft and tender, the strokes of the letters,
in the engraving are in general broader, and
have a darker appearance than in the bills.

The signature William Patterson, is badly
done, the strokes of the letters, are thick
and labored, and appear to be painted over
with the pen, as well as the flourishing of the name.

The value is left blank in the engraving, to
be filled up in writing, so the sum may be
more or less at pleasure.

The true Post Note of the alphanu-
merical mark, above described, have been lately il-
lud, and very few are now in circulation.

The above reward of One Thousand dol-
lars will be paid to any person, or persons,
who shall discover, or prosecute to conviction,
the several offenders, or any of them, of the
following description, viz.

The person or persons, who engraved the
late.

The printer, or printers of the said bills.

Every person who has acted as principal in
any way in the counterfeiting and uttering
the said bills.
