Lachawannock.

The proprietors combining their own interest with that of the inhabitants, are disposed to erect works of public utility, open roads, &c. and in every one hundred acres, a tract of one hundred acres is allotted for a School, and one hundred acres for the first resident clergyman of any denomination of Christians.
