
WHEREAS the General Affembly did, on the fourth day of April laft, refolve, "That the Governor be requefted to iffue a proclamation, reciting the act enti-led " an act to prevent intrulions on lands, within the counties of Northampton, Northumberland and Luzerne," and enjoining obedience to the fame; and that he be forth-with requefted to canfe the fame to be published in the new[papers of the flartes of New Jerfey, New York, Con-necticut, Rhode Ifland and Maffachuf-tts: and whereas the act, in the fuid refolution referred to is expressed in the following words:

nedicut, Rhode Ifland and Maffaehul-tts: and whereas the act, in the fuid refolution referred to is expreffed in the following words: "Section 1. Be it enacted by the Senate and Houfe of Reprefentatives of the Commonwealth of Pennfylvania, in General Affembly met, and it is hereby enacted by the authority of the fame, That if any perfon fhall, after the paffing of this act, take poffefinen of, enter, intrude or fettle on any lands within the limits of the counties of Northampton, Northumberland, or Luzerne, by virtue or under colour of any conveyance of half fhare right, or any other pretended title not derived from the authority of this commonwealth, or of the late proprietaries of Pennfylvania before the Revolution, fuch perfon, upon being duly convicted thereof, upon indictment in any court of oyer and terminer, or court of general quarter feffions, to be held in the proper county, shall forfeit and pay the fum of two hundred dellars, one half to the ufe of the county, and the other half to the ufe of the infor-mer, and fhall all to be fubject to fuch impriforment, not exceeding twelve months, as the coart before whom fuch conviction is had may in their diferetion direct. Sec. 2. And be it furtherena?ded by the authority afore-faid, That every perfon who fhall combine, or confpire for the purpofe of conveying, poffelfing or fetting on any lands within the limits aforefaid, under any half fhare right or pretended title as aforefaid, or for the purpofe of laying out townfhips by perfeas not appointed or acknow-ledged by the laws of this commonwealth, and every per-fon that fhall be acceffary thereto, before or after the fact, fhall, for every fuch offence, forfeit and pay a fum not lefs than five hundred, nor more than one thoufand dollars, one half to the ufe of the county, and the other half to the ufe of the informer ; and fhall allo be fubject to fuch impriforment at hard labour, not exceeding eighteen monthy, as the court in their differetion may direct. Sec. 3. And be it further enacted by the author

And be it further enacted by the authority aferefaid, That if any perfon or perfons fhall refit any officer, or other perfon duly authorifed in the execu-tion of this act, or any part thereof, every perfon or per-fons fo offending, and every perfon that thall be accelfary thereto, before or alter the fact. fhall, on conviction, for-feit and pay a fum not more than five thoufand nor lefs than five hundred dollars, and undergo an impriforment at hard labour for any period not lefs than three nor inset than feven years. than feven years. Sec. 6. AND the feveral officers of the government, and all the good citizens of this fate, are further enjoined and required to prevent or profecute by all legal means fuch intrufions and intenders, and to afford the most prompt, and effectual aid, in their feveral and refpective capacities, to carry into full execution the laws of this Commonwealth relative timeto.


