But, again, the reception of this spiritual life in the soul did not only impart present assurance of heirship, but it was permanent. The final "perseverance" of the saints was as clearly established in God's Word as any other truth. The work which Christ finished on the cross was as enduring as cternity. and therefore, where its efficacy was applied, its virtue must be equally enduring. The Son of God had finished his great work of Redemp tion alone. He had needed no assistance then; He needed none now from the hands of man to render it effective. In the hour of his bitterest trial, his disciples fiel and left him alone. He "trod the wine-press alone, and of the people there was none to help." Afterwards he had risen from the dead, and bore the blood of the atonement up to heaven anto the holiest of all. This was Christ's finished work, and to assume that its efficacy now, in the salvation of lost sinners, was in any way dependent upon the help of man was to despise the wondron^s grace of God. God did not pardon souls on trial, for it must be remembered that when he pardons sinner He does it knowing the future life of the forgiven one, just as completely as He knows the present and the past ! Of course, this complete forgiveness did not bring exemption from future temp-tation and trespasses, but it was assuredly the prerogative of the child of God to overcome, and to be numbered at last among the Lord's jewels in the

Kingdom of God. He had thus endeavored to define the real standing of Christ's true followers. The Church had a solace which could never be taken from her; though her greatest blessings were yet to come. Perfection was, of course, not attainable here ba-low. Aithough changed, redeemed, sanctified, and saved here, it was to the redemption of body and soul in the resurrection that the Christian must look for the full accomplishment of all that is promised to the saints, even to when the Lord shall appear, and they shall see him as He is, and be like him forevermare.

The sermon was delivered in the earnest and inipressive manner peculiar to Mr. Carden's style, and elicited marked attention from the large congregation who heard it.

The Catholic Church.

The late historian, Macaulay, sums up the his-tory, progress, and present condition, of the Catholic Church, in the following terse and expressive language :

There is not, and there never was on this earth a work of human policy so well deserving of exami-nation as the Roman Catholic Church. The history of that Church joins together the two great ages of human civilization. No other institution is left standing which carries the mind back to the times when the spuck of carries the mind back to the times standing which carries the mind back to the times when the smoke of sacrifices rose from the Pan-theon, and when cameleopards and tigers bounded in the Flavian amphitheatre. The proudest royal houses are but of yesterday when compared with the line of Suprema Pontiffs. That line we trace back in an unbroken series from the Pope, who crowned Napoleon in the Nineteenth Century, to the Pope who crowned Pepin in the eighth; and far beyond the time of Pepin the august dynasty extends, till it is lost in the twilight of fable. The Remultic of Yungie game next in antionity. But extends, fill it is lost in the twilight of Table. The Republic of Venice came next in antiquity. But the Republic of Venice was modern when compared with the Papacy; and the Republic of Venice is gone, and the Papacy remains. The Papacy re-mains, not in decay, not in a mere antique, but full of life and youthful vigor. The Catholic Church is still sending forth to the furthest ends of the world missionaries as zealous as those who landed in Kent with the guestin, and still confronting hostile kings with the same spirit with which she confronted Atila. The number of her children is greater than in any other age. Her acquisitions in the New World have more than compensated for what she has lost in the Old. Her spiritual ascendancy ex-tends over the vast countries which lie between the plains of the Missouri and Cape Horn, countries plains of the Missouri and Cape Horn, countries which, a century hence, may not improbably con-tain a population as large as that which now inhas-bits Europe. The members of her communion are not fewer than a hundred and fifty millions; and it will be difficult to show that all other Christian Seels united amount to a hundred up of treate milsects united amount to a hundred and twenty mil-lions.
