

The killing of the colored man, Perry Thompson, by Orderly Sergeant Charles Moore, of the United States colored troops, the particulars of which were given in full in *The Press* of yesterday, caused to be made public the fact that nearly every colored sol-dier who receives a short furlough at the camp at Chelton Hills, in order to allow him to visit this city, carries either revolvers or side arms, or both. These soldiers, doubless feel very large in the United States uniform, but while many of them wear the "harness" with the dignity always due to it, yet there are many who do not, and are, there-fore, liable to commit excesses that bring them into trouble. Many instances are known where colored soldiers have gone around neighborhoods where persuss of their own race live, and by a flourishing display of bright swords, or silver-mounted pistols, have suc-ceeded in 'rightening everybody from his or her pro-priety. Whole familiesis colored folks have been frightened in this way, though the soldiers did not probably intend to harm them; they merely asted as ior a little sport. There are other instances where these men have gone into green-groery shops and demanded liquor, under a flourish of swords or a dis-play of revoivers. This misconduct is a very great annoyance to the mess of the colored troops, who know full well the prejudies that have existed against them as a body, and which they could only overcome by bravery in the field and gentility when not in active service. It may be of some service to all soldiers, no mat-ter where they come from, or what the olor of their skin may be, whether whits, yellow, black, brown, red, to know that very recently the judges of the courd decided that no soldier while on furlough and mingling with the community, had any right what-ever to acary concealed deady weapons.
