The Price of Milk.

The Price of Milk.

To the Editor of The Press:

SIR: I will say first that I am in no way whatsoever interested in the milk business, nor am I a farmer, but a citizen and merchant of Philadelphia. I cannot see any reason why milk should not advance, and have wondered why it has not done so long ago. The writer of the article on the price of milk; in your paper of to day, does not suppose the farmer can afford to pay three times the advance on everything he uses, and sell his own production at the same price he did four years ago? The farmer used to get laborers for \$125@150 per year, now he pays \$225@250 a year; he could once buy a pair of pants for 40@50 cents per yard, now he must pay \$1.40@1.50 per yard; he could buy a yard of muslin for 12½ cents, now he must pay 75 cents—and everything else is in the same proportion. Now can the farmer offer to sell his milk at five cents per quart? I say he cannot.
