HAYANA, SEPT. 8.—THE BACISTAS FEEL ANXIOUS IN VIEW OF THE PRESENT SITUATION. THEY PRETEND THAT THE NEWS BROUGHT BY THE ENGLISH STEAMER ATRATA, VIA ST. THOMAS, ANNOUNCING THAT THE NEGOTIATION OF A BAZELT LOAN IN EUROPE OF \$2,000,000 IS A POSITIVE FACT.

KANSAS CITY, SEPT. 4.—NEWS CAME HERE LAST EVENING OF AN ARRABHOO ATTACK ON A MEXICAN TRAIN, ON THE 28TH ULT., AT PAYNEVILLE, ON THE OLD SANTA FE ROUTE, THIRTY-SEVEN MILES WEST FROM FORT DODGE.

OTHER TRAINS A FEW MILES BEYOND WERE ATTACKED. ONE SUCCESSFULLY RESISTED THE INDIAN KILLING MANY; BUT ANOTHER, LOADED WITH SEVENTY-FIVE THOUSAND POUNDS OF WOOL, WAS ABANDONED AFTER A HARD FIGHT.
