## Letter from Illinois.

### DANVILLE, Ill., Feb. 3d, 1869.

EDITOR EAGLE :- This country is fast filling EDITOR EAGLE:—This country is fast filling up with enterprising people, mostly Eastern, from Pennsylvania and New York. I believe that they are two-thirds Pennsylvanians that are here now. Last fall the roads were fairly lined with moving wagons. Emigration did not cease until near Ubristmas. Most of the peo-ple coming here will do well, though those who come without any money at all will have a hard time of it at first. An industricuts, sober and time of it at first. An industrious, sober and steady person will do better in the west than he can do east; but a porson that is not industri-ous had better stay east at present. There are as many poor people here as in the east, ac-cording to population. Property is rising in price very rapidly, and

sells at the advance.

I am pleased with this country. It has not been cold enough this winter to make ice to put up, and we fear winter is fairly breaking up. The cattle are living on the prairies with-out feed, and are doing well. This country is especially adapted to corn, wheat and oats, and is a splendid stock country. Of fruitis not so much to be said; it is a failure in two-thirds of the instances. I must mention something about our last year's crop. Wheat was a very good crop. Rye and onts were the same, but corn was only half a crop, on account of a wet spring and an early frost. The yield of potatoes was very large, and they are plenty. They are selling at one dollar per bushel. I will also mention market prices of land

and stock. Land is ranging from two dollars to fifty dollars per acre. Cattle are selling from \$16 to \$20 yearling; 2 years old from \$26 to \$36 per head. Stock hogs 8 cents per pound. Horses are low in proportion to other stock. Fat cattle are from 5 cents to 7 cents per pound gross. Fat hogs are from 8½ cents to 10 cents per pound gross.

My family are well at present. I have not had such good health since I was sixteen years of age as since I have been here, yet after all I have an inward hankering for old Berks county. I have a home feeling for bid Berks county. I have a home feeling for it that I have for no other spot. When I realize a fortune I think I shall want to go to old Berks to enjoy it.
