Over 200 delegates, representing the Republicans of Lackawanna county, met in Music hall yesterday afternoon and elected delegates and alternates to the next national Republican convention, and also nominated candidates for county coroner and county sur

Edmund A. Bartl, the candidate for county surveyor, was born Nov. 16, 1857, in Austria, and entered the en-gineer's office of the Danube Steamship Navigation and Coal company in 1872. After four years there he entered the University of Shemnite, in Austria, and was graduated as a civil and mining engineer.
