**NOLAN KILLED HIMSELF**  
 Borrowed a Revolver and Sent a Bullet into His Brain.

**HIS CAUSE FOR THE RASH DEED**

In a Letter to His Father He Intimated That His Financial Condition Was Not of the Best—Coroner Investigated the Case.

James J. Nolan, a machinist employed in the Dickson works, committed suicide yesterday morning in his home, 441 Penn avenue, over the saloon of John Shea. He fired a bullet through the roof of his mouth and into his brain and it is supposed to have died almost instantly. The coroner's inquest is thought to have been the cause of the act.

Nolan was 45 years old. He wrote letters to his wife and father before he died.

After a night of drinking it was his custom to go to work and after a few hours return home and go to bed. This he did yesterday morning and he awoke and said to his wife: "I will see you at noon." Mrs. Nolan went out at 9 o'clock to do some shopping. She returned in a half hour and found these two notes written by her husband and left on the parlor table:

Father:  
 Attach no blame to Susan, for this is an act of my own. Please use Susan good, I have abused her enough for the last few years. If I had been as good as her, things would be different. The cause of this is that I am so far in the hole I never can get out. Good-bye all; use Susan right. James Nolan.

Mrs. Nolan's Statement:  
 You will find a note in my working pockets. Good-bye. Jim.

The frantic wife rushed to the bedroom and found her husband lying dead on the floor. Apparently he had taken the revolver from the bureau and shot himself while seated on the edge of the bed.

Mrs. Nolan hurried down the stairs and told Saloon-keeper Shea what had happened. He immediately notified the Chief of Police Simpson and Coroner Kelley. They responded at once, and although no evidences of foul play existed, the coroner's inquest was held to hold an inquest. He impelled a jury consisting of John J. Morris, Michael Moran, W. W. Youngs, Daniel F. Kelly, Matthew H. Robbins and J. W. McLeary, who soon reached a verdict that the case was one of suicide.

Letter to His Wife:  
 The note left for the father indicating that the murdered man mistreated his wife is not borne out in its statement by Mrs. Nolan herself to a Tribune reporter. She said her husband had been kind to her.

Six months ago their only child died. This was a heavy blow to the father. He constantly brooded over it and never reconciled himself to the child's death. This, it is thought, had much to do with the father's violent end.

**WANT DE AYALA PARDONED.**  
 Papers Will Be Laid Before the Board of Pardons in December.

Attorneys George S. Horn and Major Edward Warren are working for a pardon for Stephen De Ayala, the wife murderer, who was convicted of murder of the second degree and sentenced to 11 years in the Eastern penitentiary by the late Judge John F. Connolly.

De Ayala was sentenced under the act that provides 12 years as the maximum penalty for murder of the second degree. Shortly afterward the legislature enlarged the penalty to 20 years.

The murdered wife was the daughter of the late M. D. May. De Ayala was tried and convicted at the December sessions ofoyer and termior court in 1921. There are seven years of his sentence yet to be served, unless the board of pardon grants him a reprieve. The board will meet on Wednesday, Dec. 18, when the papers will be laid before it.
