WILKES-BARRE. LAW UNCONSTITUTIONAL. Controller Lloyd lins No Official Exist

ence Judge Lynch's Opinion. Judge Lynch yesterday handed down

an opinion in the equity case of Joseph D. Lloyd, controller-elect of Luzerne county, against the county commissioners. The case was an application by the controller for an injunction compelling the commissioners to perform certain duties and to restrain them from the performance of other certain duties without his (the controller's) approval. In other words, to recognize the authority of the controller under the act of the legislature creating the office.

The conclusion of Judge Lynch's lengthy and intelligent opinion is in erfect that the law is unconstitutional and consequently the motion for an injunction is denied. The ground for this finding as stated in substance by the court s that the duties of the controller as defined by the law conflict with those of the county auditors, and that the law in reality removes the latter from office and takes their salaries from them, which the legislature has no right to do, the auditors having been elected for a certain term and that term having not yet expired. In his opinion the judge holds that an officer duly elected for a certain term cannot or ought not to be removed from his office without charges and hearing, which in this case have not been had.
