





The resolution sets forth that a large block of Lehigh Valley stock is owned by the estate of Asa Packer and the trustees of his estate are also officers of the railroad; it being largely through this stock contrary to the spirit of Asa Packer's will; and it is urged that a committee

of three stockholders be appointed who shall within thirty days suomic to the trustees of the Packer estate, after the same shall have been approved by the presidents of at least three of our leading trust companies a bid for the entire hat's decline; No. 2 red January, 69%. 
