TRIAL OF FILIBUSTERS.

Opinions Upon What Constitutes a Military Expedition. Philadelphia, Feb. 26.—The testimony in the trial of the officers of the steam-ship Horsa, on the charge of engaging in a Cuban filibustering expedition, was

concluded today.

Captain Ker, of counsel for the defense presented thirteen points which he desired the court to rule upon in the charge to the jury, and this led Judge Butler to express himself regarding the construction of the statute under which the secured were indiced. New York, Feb. 25.—The market for stocks was irregular today and in the main prices were inclined to weakness. Realizations seemed to be in order, more particularly in the cases of the Grangers, Louisville, and Nashville and certain of the Industrials. The reaction in St. Paul was rather disappointing n view of the large gan in net earnings for January. Rock Island was sold down from 74% to 73% on the reported destruction of the bridge at Rock Island. Baltimore and Ohio was heavy and broke to 31% on liquidations by holders who believe that the report of the expert accountant will be very unfavorable. The real features, however, were Sugar, Leather Preferred and Tobacco. Sugar was exceptionally strong throughout and rose to 113%. The strength of the stock was due to the defeat of the tariff bill in the senate yesterday. Leather Preferred was feverish and ranged between 61% and 60%, closing at 63%. The report was considered favorable. It shows profits of 89,357,854, surplus carried over from 1894 of 4786,755; total, 160,154,609; dividends paid, 33,681,000 and surplus Dec. 31, 1895, of \$6,470,609. Tobacco was heavy and fell 77% from 80. The decline attributed to selling for both accounts the result of the introduction of bills into the house of representatives of South Carolina and Alabama prohibiting the selling of cigarettes. The depression in Tobacco had an adverse influence on the general market, which left off barely steady. Net changes show losses of 4a 1½ per cent., Baltimore and Ohio leading. Sugar was an exception and gained 1 per cent., closing at 118%. Total sales were 210,966 shares.
