DRIVER IS CENSURED.

For the Fatal Accident of Mrs. Rachel Griffiths, but the Verdict Does Not Warrant Hamilton's Arrest.

Evidence upon the death of Mrs. Rachel Griffiths, the West Side aged woman, who last Tuesday died from injuries sustained three days earlier in being run down by a mail wagon on Lackawanna avenue, was heard by Coroner Longstreet and a jury Satur-day night. The following verdict cen-suring the driver, James Hamilton, was found:

"We find that the said Rachel Griffiths came to her death from injuries received by being knocked down by a mail wagon driven by James Hamilton. "We believe that the mail wagon was being driven at a carcless and unnecessary rate of speed and deprecate the fast driving prevalent in the city." The following witnesses were ex-amined: Dr. Blanchard, of the Lacka-wanna hospital: Edward Saxon, a motorman; W. H. Sunday, Fred Hawley, a conductor, Charles Hotzel, Dr. L. M. 

When Judge Gunster opened the mail box at the door of his chambers in the court house Saturday morning he found court house saturday morning he found a letter addressed to him that had not come through the person who inscribed it or by some one at his instance. The judge opened it and read it. The contents were of a nature not calculated to engender feelings of serenity of tem-per, for bold charges were contained in the missive against the judge. The sender of it was Attorney Cornelius Smith.

Judge Gunster placed the letter in his pocket and went out with the other judges to hand down the list of liquor licenses. After this function had been performed. Messenger B. Newton was sent to Mr. Smith's office with in-structions to make known to him that his presence was immediately desired in open court. In due season Mr. Smith made his appearance and he walked down the center alse of the court room in a dignified way with his slik hat tipped against his bosom in a deferon the bench and he stood up to the bar with a quizzical look on his face.

The court room was crowded with men attracted to license court and the bar enclosure was stocked with attorneys. The silence was stocked with attor-scene was dramatic when Judge Gunster faced Mr. Smith and addressed him thus: "I received a communica-tion from you which purports to be



It being stated to me that in open court you announced your opinion in the case of Burns vs. Smith, et. al., discharging the rule to show cause why the appeal should not be stricken off, and at the request of Mr. Kasson and Burns, in my absence, you took the opinion back. Upon further inquiry this statement was confirmed by other gentlemen who were present in court. 




