## TOM POWER.

President Young, of the National Board. Writes to Kunztsch--Power and Kuntzsch Don't Agree-Letter to Mr. Simpson.

Special to the Scranton Tribune.

Syracuse, N. Y., April 23.—George N. Kuntzsch received notice from President Young of the national board of arbitration today that Tom Power has asked the board to declare him free from contract with the Syracuse club. Power has put his contract signed September 12, 1895, in evidence. This contract on its face is indefinite, and

of the season of 1895. He says he signed no contract with Syracuse at the beginning of the season or in 1894. Mr. Kuntzsch sent to President Young his sworn affidavit that he offered Power a contract for 1896 on

Power claims was for the remainder

September 12 for \$175 a month, which Power refused to sign; that he raised the amount to \$200 and Power signed; that Power was put on the reserve list, and until this no kick has come from him. Mr. Kuntzsch has also written Simp-

son, of Scranton, that he will hold Power to his contract if it costs the price of his release.

Power has not showed up in Syracuse. His whereabouts are not known.

In substance the Power situation is this: If President Young decides that Power is reserved by Syracuse he must submit his terms to Scranton and play here if her terms are accepted. If his terms are unsatisfactory Syracuse must return the \$200 purchase money to Scranton and Power will be subject to Kuntzsch's orders. If, however, it is decided by President Young that there is no contract between Kuntzsch and Power, the player can negotiate with whom he pleases. The Tribune knows, however, that Power has already negotiated with another club, and we have good reason to believe that club is Springfield.
