REMARKABLE FATE OF PEDRO ROXAS

Spain Deports the Leading Man Manila to Ceuta.

MILLIONIARE BETRAYED BY HIS WIFE

He Was to Have Been the First President of the Philippine Republic, Had Spain Been Whipped. Told His Wife, Who Confessed to a Faithless Clergyman.

New York, Dec. 2.—The Sun prints the following remarkable story of the fate of Pedro Roxas, the leading man of Manila and the man who had been picked out as the first president of the new Philippine republic in case the re-bellion against the Spanish rule on the islands was successful. The story has to do with Roxas' wife and her conlessor, who is alleged to have violated

the sacred vows of secrecy.

Roxas was a sugar planter. He was a meshzo, or half caste, his father being a Spaniard and his mother a native of the islands. As a sugar planter and exporter of sugar and hemp. Pedro Roxas accumulated a fortune. He was finely educated, speaking English, Spanish, Tagaloy (the native language) and Chinese. He was broad-minded and liberal, and gradually came to be looked on as the most progressive of all the native citizens of the islands. He was the organizer of the electric light company, the street railroad company, the bank, and most of the other institutions or modern civilization that have been introduced in the city of Manila or elsewhere on the islands. He came to be beloved by everybody except the Spanish government. The Spanish dislike of him was natural, because his desire for progress was not in keeping with the bigotry and intolerance of their government. improved of late on account of the more seasonable weather. No change in prices is expected this year, and it is claimed that prices are not far from the September circular. There is au-thority for the statement that most of the coal that has been moved in the last three months and is being shipped at present was sold fully 25 cents per ton below the September basis. Cut-ting of prices has been done by indi-vidual operators and through jobbers. There is plenty of coal at the west and better prices have been secured than in any tide water market. Coal has been accumulating at the act. has been accumulating at the east, but continued cold weather is expected to relieve the market. It can be safely assumed that, although the agreement between the anthracite coal presidents nominally expires on Jan. 1 next, no change will be made in the conduct of the trade. LIVE NEWS FROM THE OLD WORLD

Egypt Must Now Refund Expenses of the Dougola Expedition.

France's and Russia's Objections Finally Sustained -- Rumors Persist That the Situation is Critical Despite Official Denials -- German Political Secrets -- Hamburg's Big

Alexandria, Egypt, Dec. 2.—The court of appeals today issued its deci-sion in the famous case of the Caisse of the Egyptian debt and the government, and condemned the latter to re-pay the funds advanced by the Calsse for the purposes of the Anglo-Egyptian expedition to Dongola.

The commission of the Egyptian debt, otherwise the Calsse, on March 25 last decided to advance from the re-

serve funds \$2.500,000 needed to meet the expenses of the British-Egyptian expedition to Dongola, and eventually did so. The English, German, Italian and Austrian members of the commis-sion voted in favor of the proposition. The Russian and French members vot-ed against it. Almost immediately afterward the representatives of the Paris syndicate of Egyptian bondhold-ers took steps to institute proceedings against the Caisse for advancing this, and the mixed tribunal, on June 8, decided against the government, stating that the advance was made in violation of all existing decrees, and con-demned the government to repay the money advanced and enjoined the commissioners from advancing any fur-ther money for the war expenses. The Egyptian government and the four commissioners referred to then lodged an appeal against this decision, and the matter eventually came before the court of appeals, with the result an-nounced in the above dispatch.

GERMAN POLITICAL SECRETS.

They Are Expected to Come Out in a Berlin Libel Suit.

Berlin, Dec. 2.—The trial of Herr Leckert, Baron von Luetzow, Herr Fio-etz, Herr Berger and Herr Foellmer, the journalists, who are charged with libelling Count von Eulenberg, Baron Marshal von Bieberstein and Prince Alexander von Hohenlohe commenced today. The case arises from the two-fold versions of the czar's and Emperor William's toast at Breslau, and the alleged libels are contained in comments on the modified official version of the toast in asserting that the publication of the first version, which the libel construed as unfriendly to Germany, was due to the frresponsibility of the government and to English in-

fluences Herr Leckert refuses to divulge the name of the person who gave him the information upon which he based his criticism, but he is believed to be a Berlin official. The trial is causing sensation among political circles, as expected to reveal the workings of the court elique, which, dominated by the former minister of the interior, Count Botho von Eulenberg, the latter's cousin, the present court marshal, and Richthofen, the ex-chief of police, is credited with bringing about the downfall of General von Caprivi, the predecessor of Prince Hoheniohe as imperial chancellor. They are also charged with being the instigators of the press war waged for a year past against Prince Hohenlohe, the chancellor, and Baron Marshal von Bieber-stein, the minister for foreign affairs. This clique has heretofore been sup-

posed to enjoy the confidence of Em-peror William, and Prince Hohenlohe and Baron von Bieberstein, both of whom are to be called to the wi stand, intend to expose the whole of the clique's attempts to force them

resign. Herr Leckert and Baron von Luetlow were examined at length, and the latter admitted that he was the chief author of the articles complained of, adding that Herr Leckert hinted that he had obtained the story of the changed versions from an official of the foreign office.

HAMBURG'S BIG STRIKE,

Men Willing to Arbitrate, but the Employers Decline.

Hamburg, Dec. 2.—At meetings which were attended by about eight thousand strikers this morning, resolutions were adopted providing for the acceptance, in behalf of the strikers, of the proposition made by the Chief of Police, the president of the municipal council and the chairman of the Trades' court, that the dispute of the dockers and their employers be submit-ted to a court of arbitration composed of the officials mentioned and, in addition, one leading employer and four labor representatives, the decisions of this court to require a majority of six out of the eight votes. The represen-tatives of the strikers also selected the four men to represent them in the court of arbitration.

At a meeting of the employers' union

today it was unanimously resolved to reject the proposal to submit the dockers' dispute to a court of arbitration.


