DEFECTS IN MINING LAWS.

A Movement to Place the Mine Inspectors Under State Supervision. To correct the defects in the state mining laws a general act will be introduced in the next legislature which will apply to the anthracite and bltuminous regions of Pennsylvania. The measure will have the sanction of the state authorities and will establish a bureau of mines in the internal affairs department with a chief whose qualifications will be similar to those required of mining engineers and mine inspectors, The creation of such a bureau with a properly qualified chief is thought to be necessary for the reason that no supervision by the state is by law authorized over the mine inspectors of either the anthracite or bituminous mines in

Pennsylvania. Complaints are constantly being made to the governor and other state officials by operators, miners and others connected with mines against the inspectors for alleged failure to comply with the duties imposed upon them by law, but the state authorities bave n legal right to investigate such complaints and nothing is ever done in the matter, except to refer them to the inspector who has been complained against. As it is now there are to all intents and purposes eighteen different departments of mining in this state, each mine inspector transacting the business of his district according to his own ideas without being accountable to a superior officer on the part of the commonwealth, and yet all inspectors are paid directly from the state treasury. The state authorities back of the proposed act claim there is need of additional mining legislation on account of the alleged unconstitutionality of the
