MONETARY MEETING AT INDIANAPOLIS

Various Schemes Suggested in the Interest of Honest Money.

E. C. CAMP ADVOCATES HIGH TARIFF

The Tennessee Delegate Would Also Retire the Greenback at the Rate of \$100,000,000 a Year--Mr. Cobb Compliments Governor Stannard. A Burst of Applause at the Name of Grover Cleveland.

Indianapolis, Ind., Jan. 13 .- At 10.30 the monetary convention was called to Frankenstein, aged 16, fatally hurt at order by Chairman Patterson. The secretary read a telegram from the Jersey City board of trade amid applause, commending the objects of the convention and expressing its intention of standing by it in the fight for honest money and the natioal honor.

F. H. Madgeburg, of Milwaukee, presented a series of resolutions representing the views of the business men of that section. It demanded legislation for the refunding of government demand notes in long time bonds, with a compensating issue of national bank

E. O. Stannard, of St. Louis, sent up a plan formulated by W. C. Little, a merchant of that city, the main features of which were similar to the demands made in the Milwaukee resolutions.

The secretary read the titles of a large number of schemes of revision and relief which had been forwarded to the executive committee by their au thors, and they were all referred to the

committee on resolution. 'Bimetallism Is the Universal Stand ard, by an American," evoked an audi-

ble smile. Charles E. Adams, president of the Massachusetts state board of trade, offered a resolution recommending the organization by states of business men in order to expedite the gathering of

similar conventions in the future. E. C. Camp, of Knoxville, Tenn., suggested that we pay our debts as a government as we would as individuals. He advocated a tariff law sufficient to yield a revenue of \$650,000,000 and the gradual retirement of the greenbacks and other government indebtedness at the rate of at least \$100,000,000 a year.

COMPLIMENTS TO STANNARD.

Mr. Cobb. of Massachusetts, on behalf of his delegation, said they were so well pleased with Governor Stannard's opening address that they desired to commend it to the committee on resolutions for its consideration in preparing its declaration of principles. Governor Stannard asked that the motion be withdrawn in reference to him. but Mr. Cobb stated that he desired it presented as representing the sentiments of his delegation. It was so ordered.

The meeting was on motion of Mr. Chadwick, of Brooklyn, then thrown open for an exchange of opinion, speeches being limited to five minutes. Nobody offering to speak, calls were

made for Chadwick. Mr. Chadwick gave the history of the establishment of legal tender obligations issued by the government.

Representative Fowler, of New Jersey, was asked to speak, but if required a division of the house to pass a motion to suspend the operation of the five-minute rule in his favor.

#### Four Men Horribly Mangled in a Mine at Pottsville.

Pottsville, Pa., Jan. 13 .- William L. Taylor, aged 40; Henry Flinn, 35; John Taylor, 24, and Peter Tinco, a Polander. 30, were instanly killed and Theodore

the Philadelphia and Reading Coal and Iron company's new shaft at Wadesville this morning. Frankenstein died soon after the accident.

The men composed a part of the day shift and stood on the brim of a big iron bucket to be lowered to the bottom of the shaft, a distance of six hundred feet. The rope passed through a heavy cross head, made of angle iron which served as a guide for the rope. On account of the bitter cold weather the cross head did not move when the men started down the shaft. After they had descended about 300 feet the cross head fell crashing on top of the bucket and precipitating the four men and boy to the rocky surface below, a distance of about 275 feet. The bodies of the four men were horribly mangled.

John Taylor had never seen the bot-tom of the shaft, this being his first day to enter the workings. The men who were killed all have families.

## MAY PROBE THE CHARGES

### Legislator Williams Will Ask for an Inquiry Into Methods of Rival Factions in Senatorial Contest.

From the Harrisburg Patriot, Jan. 13. S. Marshall Williams, of Everett, a member of the house of representatives from Bedford county, wants a legislative inquiry into the charge of bribery and corruption in connection with the late fight for United States senator. Mr. Williams is preparing a resolution for a joint committee of the house and senate to inquire into the stories that large sums of money were used by the friends of Penrose and Wanamaker among legislators to secure votes. He was in Harrisburg yesterday and said he was not yet ready to say when he would offer his resolution. He will consult Senator Penrose and Quay men before taking final action. The resolution will authorize the committee to issue subpoenas for witnesses and call for telegrams, letters

and other correspondence. Mr. Williams is a Quay man and was an active assistant at the Penrose headquarters during the heat of the senatorial con-test. APPROVED OF THE WORD GOLD. The congressman's emphatic statements in favor of the use of the word "gold" instead of "coin" in national obligations, and against further discussion of the silver coinage question. met the very decided approval of the convention, being frequently applauded. At the conclusion of Mr. Fowler's address he was surrounded by a crowd of admiring delegates, whose warm congratulations somewhat interfered with the immediate further proceed-

On motion of A. H. Vanslaack, of Chicago, the paper by Congressman Fowler was referred to the committee on resolutions. A proposition to instruct the committee to incorporate its sentiments in their report was rejected as an infraction of the rules. A rising vote was given to express the satisfac tion and appreciation of the convention with the address.

Lleutenant Governor Huggard, of Indiana. transmitted a resolution passed by the state senate inviting the members of the convention to visit the senate, the courtesy of the floor to be extended to them. The invitation was accepted and to avail itself of the invitation a recess was taken until 4 o'clock.

When the delegates reached the state house they found the senate had adjourned.

#### Four Business Firms Burned Out at Wallaceburg, Canada.


