### SENATOR TURPIE SPEAKS UPON CUBA

He Favors an Immediate Declaration of Belligerency.

BITTERLY SCORES GENERAL WEYLER

The Spanish Leader Is Characterized as a Diminutive Reptile -- Eulogies Are Delivered on Ex-Speaker Crisp. A Lot of Miscellaneous Business Disposed of by the House.

Washington, Jan. 25.-The condition of affairs in connection with the choice of a senator from the state of Delaware was called to the attention of the senate today by Mr. Burrows, of Michigan, who presented a paper signed by the three presidential electors for that which it is asserted that through illegal and fraudulent action a majority of about 500 Republican votes in Kent county had been changed into a Democratic majority of about 200. Mr. Burrows also presented a paper signed by the speaker of the senate and the speaker of the house, asserting that legislators chosen by the people were evicted from the state capitol and that the powers of the state government was usurped by a corrupt eligarchy. Both papers urge the senate to take action in the premises. In connection with the same subject Mr. Chandler, of New Hampshire, announced his intention to suggest to the senate whether some method cannot be fixed "to prevent the wholesale larceny of senatorships in various states."

A resolution was offered by Mr. Pettigrew, of South Dakota, and was referred to the committee on contingent expenses for a select committee to inquire into the issue of land patents to the Pacific railroads and as to the diversion from the gross earnings of the subsidies paid by the companies to the Pacific Mail Steamship company. A bill providing that no person shall be tried in a United States court for acts in aid of the republic of Cuba, was And then, in pursuance of previous notice Mr. Turpie, Indiana, addressed the senate in a long constitutional argument to prove that the primary and paramount power to recognize a new state is vested, not in the president of the United States, but in congress under that clause of the constitution which declares that congress shall have power to regulate commerce, that is, according to Mr. Turple, intercourse with foreign states. He spoke for two hours and a half and had not concluded when the hour fixed for eulogies on ex-Speaker Crisp, of Georgia, arrived. In the course of his speech he indulged in vituperation of Captain General Weyler as an "indescribably diminutive reptile," as a "man who used lifs sword against women and chil-

After disposing of about a quarter of the text of the bill, which includes eighty printed pages, the house at 5.10 o'clock adjourned until tomorrow.

The conference report upon the immigration bill was presented by Mr. Danford, of Ohio, who gave notice that he would ask the house to take it up Wednesday and dispose of it.

Bills were passed to regulate the disposition of dead bodies in the District of Columbia, and to prevent the spread of contagious dise ases in the district. A senate bill was passed directing a survey from the mouth of the Jetties at Galveston, Tex., through Buffalo Bayou to Houston.
