

AMENDMENTS TO ARBITRATION TREATY

All Reference to the King of Sweden is Eliminated.

THE SECRECY INJUNCTION REMAINS

A Resolution to Determine the Condition of Delaware Is Offered—The House Refuses to Consider a Measure Aimed at Railroad Ticket Scalpers—Various Bills Approved by the Lower Branch.

Washington, Feb. 1.—Immediately after the senate convened at noon Senator Sherman moved an executive session, stating that it would require but a short time. When the doors were closed he reported the general treaty of arbitration as amended Saturday by the committee. The first of these amendments, as previously stated, in these dispatches, adds at the end of the first article the clause:

But no question which affects the foreign or domestic policy of either of the contracting parties, or the relations of either with any other state or power, by treaty or otherwise, shall be subject to arbitration under this treaty, except by special agreement.

The second strikes out all references, wherever it occurs, to the King of Sweden and Norway as the umpire where the tribunal fails to agree upon their umpire.

After the report was made Mr. Sherman asked that, inasmuch as the text of the convention has been made public, the injunction of secrecy be removed from the text of the amendments, but Senator Morgan objected and the request was denied. No attempt was made to arrange a time for the consideration of the treaty nor was anything said about debating it in open session.

SCALPING BILL IGNORED

The first thing the house did today was to refuse to consider the bill reported by the committee on interstate and foreign commerce to prohibit railroad ticket scalping. In the course of the session which was devoted to miscellaneous business the following bills were passed:

To prohibit the carrying from one state into another of obscene literature or articles designed for indecent or immoral purposes; giving officers in the volunteer service of the United States the brevet rank held by them and the right to wear the uniform of that rank; protection of national military parks; protection that surgeons of soldiers' homes may be appointed from other than those who have been disabled in the service of the United States; extending the authority of the president of the United States to issue medals of honor to other than officers and enlisted men; to restore to his former rank in the navy and place on the retired list John S. Quincey, granting to Colorado 557 acres in Fort Lyon reservation for a state soldiers' home; authorizing the entry of public lands containing petroleum under the mining laws; directing the issue of patents for the located but unconfirmed lands in Louisiana, 288 tracts containing about 80,000 acres.

The last hour of the session was devoted to the consideration, in committee of the whole, of the diplomatic and consular appropriation bill.

trial by Dr. Johnston's attorneys. February 18 has been fixed when the application will be argued. When Dr. Johnston was brought into the court room he looked pale and anxious, more so than at any time since the trial began Wednesday a week ago, and when the verdict was announced he came very near fainting. It was a relief to him to hear it having been learned that he had expected a verdict of acquittal. Mrs. Johnston became hysterical at the Rhinesth hotel, where she is stopping. The court room was well filled with spectators and the excitement here is very great, while at Dunsmuir the people are pleased with the verdict. Had Dr. Johnston been acquitted he would not have been released, but sent to some insane asylum by Judge Lyons for at least three months, or until he had sufficiently recovered from the delusional insanity under which he is laboring.

This has been the most expensive trial Perry county has ever had, and it is estimated \$15,000 will not cover the cost of attorneys' fees, etc. Drs. Moulton, Wood and Mills, the experts on insanity, are credited with receiving \$1,000 each, while three of Dr. Johnston's attorneys, Bergner, Shull and Seibert, got \$1,000 each, and Mr. Beck is said to have gotten \$3,000, and \$2,000 additional if his case is acquitted. The four counsel for the commonwealth, ex-Judge Barnett and son, ex-Senator Smiley and Mr. Weidman, are said to have received \$500 each. There were over 140 witnesses present for eight days.

MARKETS AND STOCKS.

Wall Street Review.

New York, Feb. 1.—Stocks were irregular, but in the main firm. The irregularity was attributed to the desire of the senate committee to amend the general arbitration treaty. London firms sold fairly large amounts of the international stocks on this account and professional operators short of the market attempted to force liquidation. Very little impression was made on prices, except in a few instances. Manhattan and Lackawanna, however, were rather feverish and did not receive the support accorded the general list. There was good buying of the Northern Pacific and the new preferred rose to within a fraction of 90. Louisville and Nashville was higher on the favorable report for December. In the industrials, Chicago Gas was in request; speculation closed irregular, but in the main firm. Net changes show losses of 1/4 of 1 cent. Western Union, Northern Pacific preferred and Omaha, however, gained 1/4 of 1 cent. Total sales were 18,000 shares.
