**EDHEM PASHA IS RECALLED** 

Greek's Gaining Ground, According to Dispatches.

In Epirus the Greek Army Is Advancing and Turkish Inhabitants Are Fleeing Before It -- the Turks Dismayed at the Loss of Their Stores at Katerina and at Litochorion. Greeks Are Pleased at Expressions of Sympathy from the United States. Patriotic Ardor Is Running Higher.

New York, April 23.-The news from Greco-Turkish war this evening is distinctly favorable to Greece Information of advantages gained by her forces at several points, on land and sea, is corroborated by the significant announcement that the porte has sent Osman Pasha, the veteran hero of Plevna, to take command of the Turk-Ish army before Larissa, superseding Edhem Pasha, who is recalled. It is also announced that 50,000 reserves have been called out to reinforce the Turkish troops already at the front. Ahmed Hifsi Pasha has been replaced in command at the Tirkish headquarters at Janina by Said Edhem Pasha.

Advantages, according to today's dispatches, have been gained by the Greeks in the defense of Larissa, and by its fleet in the east and west as well. ### TURKS DISMAYED.

#### Edhem Pasha's Troops Disconcerted at the Loss of Their Stores.

London, April 23.-The Athens correspondent of the Daily Chronicle says that the Crown Prince Constantine has wired Kink George as follows: "The Turks are quiet today owing to

our success yesterday (Thursday). We have destroyed the Turkish battery at Ligeria. The Turks have retired from Nezeros and Rapsani. The action of our fleet at Katerina was excellent. I was in the first line of fire yesterday." The Chronicle's correspondent says:

The Turks are greatly dismayed by the destruction of their stores at Katerina and Litichorion, Commodore Sachtouris destroyed the stores from the coast to the foot of Mount Olympus Nothing remains, therefore for Edhem Pasha to carry away but hunger. The coast road being barred, the only remaining road from Salonica is the Verria road, eight days from Elassona. The reports of the injury to the railway line by the blowing up of the bridges and a tunnel are confirmed.

Financially, everything is going well and the value of paper money has risen. It is reported here (Athens). that the Turkish troops will be withdrawn from Crete. Private advices from Volo say that all the villages between Katerina and Verria have risen-

Among the wounded who have arrived here are several who state that a number of the Greeks wounded at Gritzovali and unable to follow the Greek setreat, were shut up in a small church by the Turks, who set fire to the building and burned them to death.

CALL FOR THE LANDWEHR. Athens, April 23.-It has been decid-

to call out several classes of the Landwehr, or militia. In Greece all able bodied males from years of age and upwards are liable

to be called upon for military service. The total service is for nineteen years, of which two years (with considerable terms of leaves of absence) must be passed with the colors; eight and seven years are then passed in the reserve and the remainder of the total term of nineteen years is passed in the militia or Landwehr.

Corfu, April 23.-The western Greek squadron is bombarding Santi Quaranta and doing great damage to the town. All the government and private buildings have been destroyed, with the exception of the Austrian agency. All the stores and merchandise on the quays have been burned.

Thorp ran his electric car up behind the buggy and sounded the gong. Stansbury was driving fast and refused to turn out, and Thorp ran his car up to the buggy and bumped it off the track. Stansbury stopped his horse, lowered the good of his buggy, drew a revolver from under the seat and shot the mo-torman through the thigh. When arrested by an astonished policeman, Stansbury was perfectly calm. He said he had as much right on the street as a car and that no motorman and any franchise to run him down. I wish you would give notice to the gentlemen charged with the duty of assigning seats to the different invited guest of the city that they should assign proper places to the ambassadors and ministers of foreign nations, as well as to the presi-dent, vice-president and members of the cabinet, without any preference to one body of visitors over another,

New York, April 23.-Detective Sergeant Wale and a corps of central ofupon four alleged "bucket shops" at Nos. 49, 51 and 53 New street and The raid on all the places was made

simultaneously at 1.35 o'clock and created great excitement. The places raided were the Manhattan Commission company, where three men were taken into custody; the Standard Commission company, where five were arrested; Woodruff's Commission brokerage at No. 40 Broadway, where three prisoners were secured, and the Equitable Commission company, where three

At, No. 51 New street a cry of "police" was raised as soon as the detectives entered the doors. Instantly there was a desperate scramble on the part of the patrons of the place to reach the street. The detectives fought the crowd back and threatened the foremost with bod-

A silk hat belonging to a customer was knocked off his head, and, flying past the detectives, rolled into the street. There a crowd had congregated and shouted encouragement with great impartiality to the detectives as well as to the men struggling to get out of the building.

After a sharp tussle the detectives ucceeded in driving the patrons of the place back, so that the doors to the street could be closed. Then the detectives were forced to renew the fight, as the customers attempted to escape

"Keep quiet. This is not a shouted: hanging matter! We only want the managers.

After a few minutes it dawned upon the score or more patrons in the place that they were not liable to arrest, and comparative quiet was established. Then the detectives rushed behind the partition and placed the manager and chief clerk under arrest. Being satisfied that all others in the establishment were merely patrons, they permitted them to depart.

The prisoners denied emphatically having any onnection with the business, but the detectives decided to let them explain matters to the magistrate, and they were taken along with the other prisoners to court.

HONEYCOMBED BUILDINGS. The buildings in which the men who were arrested were transacting business run through from Broadway to New street. They are old buildings, and the ground floors are intersected at all angles with alleyways and pas-The structures are literally sages. honeycombed with the offices of alleged brokers.

Every little nook and cranny seems in each a rushing business was being transacted when the detectives pounced down upon speculators and caught them like rats in a trap. Each office was equipped with the regulation blackboard, tickers, telegraph wires and several telephones. The latter instruments in the offices raided proved, on being tested, to be dummies. There was some one at the back of one, however, for in reply to the question, "Who's that?" a voice shouted "Con-solidated Exchange." The telegraph solidated Exchange." wires on being followed out were found to lead into the basement and end there.

#### Race War Started in an Indian Territory Village.
