GOVERNOR SIGNS THE WEILER BILL

A Measure Endorsed by the Labor Organizations.

HEIDELBAUGH TURNED DOWN

He Is Refused a Special Order for His Sunday Foot Ball, Base Ball and Golf Restricting Bill -- The Uniform Steam Passenger Rate Scheme

Marrisburg, Pa., June 4.-The house refused this morning by a vote of 63 to 49 to recommit to the municipal corporations committee the Becker bill relating to the confirmation of appointees of the mayor of Philadelphia. Heidelbaugh, of Lancaster, was refused a special order for his bill to prohibit the playing of foot ball, base ball and golf on Sunday. The house also refused by a vote of 99 to 58 to make a special order for the bill of Mr. Baldwin, of Delaware, for the attachment of wages for the purchase of food sup-

A special order was granted on mo tion of Mr. Bentley, of Erie, for a bill to cover into counties money uncalled for after ten years for the use of boroughs, townships and cities. The bill will be considered Monday night on second reading, and Tuesday morning with the members responsible for the on third reading. A lively debate was precipitated by Mr. Creasy, of Columbia, moving to place on the calendar the negatived bill fixing the uniform passenger rate on steam railways at two cents a mile. This measure has been before the legislature at every session for ten years and has always been killed by the railroad committee. Mr. Creasy's motion was defeated by 19 yeas to 97 nays.

Mr. Hammond, of Westmoreland, was refused a special order for senate bill empowering boroughs and town councils to annex adjacent lots on petition of the property owners, after which the house adjourned until Monday at 8.30 p. m.

GOVERNOR SIGNS WEILER BILL.

Governor Hastings this afternoon signed the Weiler bill to protect the employes of corporations in their right to belong to labor organizations. The measure passed the house and senate without an objection and was strongly endorsed by all the labor organizations in the state. The governor also signed the Muchlbronner bill relating to street improvements in cities of the

The Weiler bill is to protect employes of corporations in their right to form, join or belong to labor organizations by prescribing penalties for interference therewith. Any officer, agent or employe of a corporation found guilty of coercing or attempting to coerce any employe by discharging them or threatening to discharge them because of their connection with any lawful labor organization shall be liable to a fine of not more than two thousand or less-than one thousand dollars and one year's imprisonment.

GOVERNOR'S VETOES.

He Declares the Game Bills Un-

constitutional. Harrisburg, Pa., June 4.-Governor Hastings has vetoed the act prohibit-Easton, Pa., June 4.-Absconding ing the catching or selling in Bradford county of any grouse, pheasant, quall, partridge, woodcock, wild pigeon, trout or bass on the ground that the act is unconstitutional, and he has already approved the general act relating to the preservation of game prepared by the state game commission.

He has also vetoed the joint resolution providing for the printing of a series of costly atlases to go with geological reports already printed on the ground that there is no provision or limitation regarding the cost and because of the present condition of the state treasury.

IT IS UNCONSTITUTIONAL.

Judge Hanna's Ruling on the Direct Inheritance Tax Law.

Philadelphia, June 4. - President Judge Hanna, of the Orphans' court, this afternoon in adjudicating the estate of George Blight, deceased, decided that the new direct inheritance tax law is unconstitutional. The law was recently passed by the legislature as a revenue measure and was expected to add between \$600,000 and \$1,000. 000 annually to the revenues of the

The question will probably be carried to the supreme court for a final decision.

The people of Cuba and the people of this country are becoming tired of hearing that our government, while refusing to give Cuba the recognition for which she asks, contemplates doing for her something better, however, will involve a good deal of delay and the acquiescence of the Spanish government. That was the siren's song sung by the Cleveland envoy, Senor Dupuy de Lome, pretended to offer certain reforms to the unhappy sland, reforms which the Cubans at once repudiated, and which the Cortes has since declind to ratify. Equally delusive is the talk about buying the independence of Cuba by guaranteeing a huge sum in Cuban bonds to be turned over to Spain by way of indemnification. The time has gone by when the rescue of Cuba from Spanish savagery could be brought about by purchase. The leaders of all the chief political carties in the peninsula have joined in declaring that never will Spain consent to sell the island, and the Cubans themselves refuse to pay a penny for the liberty which they know themselves capable of gaining by arms. The revolutionists stand today precisely where our forefathers stood in 176. They have gone too far for compromise: they can never trust agrin the promises of the mother

Why is it that our Federal government hesitates to do for the Cubans what was done by Madison and Monroe for the Spanish-Americans of the mainland during their uprising against tyranny? "From an early stage of the struggle," as we learn from one of Monroe's messages, and from the instructions of Sceretary J. Q. Adams to Mr. Rush, President Madison recognized the Spanish-Ameritary J. Q. Adams to Mr. Rush, President Madison recognized the Spanish-American insurrectionists as beligerents and HESSLER Paterson, N. J. bserved an impartial neutrality between them and their Spanish opponents. At he proper time President Monroe ceeded to take the step next in order by recognizing the Spanish-American comnunities as independent States. Neither of those Presidents offered to mediate be-tween the oppressed and the oppressor occurred to neither of them as possible that in a struggle for liberty there might be something to be said on both sides; by neither of them was despotic Spain countenanced in a lying proffer of sham reforms; neither propsed to help the insurrectionists to buy the freedom which they were fighting for. Madison and Mon-roe themselves had played a part in our own war for independence; they were keenly alive to the truth that "who would be free himself must strike the blow;" but they also felt it to be the duty of onlook ing republics to give new aspirants for liberty a fair field, and to see to it that no favor was enjoyed by their antagon-ists. To that end they withheld from Spain every privilege which was not equally open to her revolted subjects; and they promptly extended to the latter such a measure of recognition as would enable hem to turn their own resources to ac count, and would assure to them decent reatment in accordance with the laws of civilized warfare. That is all the Span-ish-Americans of the mainland got from us; it was all they asked; and it sufficed. Defeated and bankrupt, Spain had to let hem go without a dollar of indemnity.

What have the Cubans done that they leserve at our hands less ympathy and encouragement than their Spanish-Amer-can brethren received? Will it be said that our Federal government is naunted by the spectre of Hayti, and dreads to see independence achieved by an island which contains a large colored population? No such apprehension can be honestly felt by men acquainted with the facts; and men unacquainted with the facts have no business to be trusted with the powers of government, in Hayti, at the time of the insurrection, the blacks and mulattoes outnumbered the whites in the proportion of 20 to 1; in Cuba, at the date of the last census, the whites outnumbered the colored people of all shades in the propor-tion of 2 to 1. The whites in Cuba today constitute a far larger proportion of the pepulation than they did in any of the other Spanish-American colonies, the beligerency of which we recognized at an early stage of the struggle, and the inde-pendence of which we acknowledged in 1822. Why, then, do we continue to withhold our countenance from Cuba? Is it because her children have not fought long enough, or hard enough? They tain under her colors in the island for up-ward of two years an army of 200,000 men, a much larger force than she was able administration, and the wretched outcome of it was a fraudulent agreement, by which Prime Minister Canovas and his which our own forefathers had to grapple in our Revolutionary war.
