TO UTILIZE CONVICT LABOR. Suggestion to Secure the Completion of the Cape Cod Canal. The Cape Cod canal would be built by convict labor and as a public enterprise if the bill of Willard Howland, which before the Massachusetts legislature, should pass. Mr. Howland points out that all the private corporations proposing to build this canal have failed to raise the necessary capital, and there is little prospect of future success in that line, says Mr. Howland. At the present time more than half of the 5,000 convicts whose labor is available are now unemployed, and it is costing the state \$750,000 annually for their maintenance. He proposes to use only short term prisoners on this work, and would build the canal as a

state enterprise. The scheme is approved by the superintendent of prisons. Mr. Howland cites the employment of convict labor for the building of the English dockyards at Portsmouth and Chatham, the port at Plymouth and the breakwater at Fairfield, as examples of work of public benefit that could not be obtained through private enterprise. The proposition is likely to give rise to considerable discussion and is regarded with favor by many interested in the affairs of the commonwealth.
