
BEFORE BREAKFAST, 555

THAT STATE MONEY FOR THE FIREMEN

name of Charles Coleman, of this city. City of Scranton Is Entitled to Receive Over Two Thousand Dollars.

HOW CAN THE FIRE LADDIES GET IT

That Is the Embarrassing Problem That Confronts Them .- Opinion of the City Solicitor of Allentown on the Subject -- Way That It Is Proposed to Bridge the Difficulty Here .- The Firemen Will Organize a Relief Board.

In response to a communication adressed by City Treasurer C. G. Boland to State Treasurer Haywood and by him referred to the auditor general the following letter has been received by Mr. Boland:

Dear sir: The state treasurer has referred to this office your letter of the 31st ultime in the matter of the portion of the state tax on the premiums of foreign fire meurance companies to which you in answer therete I have to say that the share of your city for 1896 will be \$2,-261.27, and that this amount will be paid as soon as the computations of the vaous amounts due all the boroughs and ties have been made, which I suppose will be about the first of September, but probably not trill a little later.

The intention of the men who framed the law was to have this money to into a fund in the cities, boroughs and townships of the state for the relief of firemen who became sick or disabled while in the service. That intention could not be expressed in the bill for it would render it unconstitutional. There was a tacit understanding, however, that the money should be used for the relief of the firemen.

FIRST PROPOSITION. It was at first proposed that firemen's relief associations be organized and the money due to each city, borough and township be paid into the treasury of such associations. This it was found would be illegal as the act does not specify that the money shall be credited to any particular fund and councils have not the power to appropriate money from the general city fund for charitable purposes. The only question therefore to be con dered is whether the city has a right, nder its charter, to appropriate money the Allentown Firemen's Relief asso-It is a well known principal of unicipal law that a city has no powers xcept such as are expressed in its chartorder to carry out the object of its corporation.

The acts of assembly governing cities of the third class does not contain any rant of power which would authorize city to appropriate money to the Fire nen's Relief association. In fact if such ower were contained in the acts of as-

The constitution of Pennsylvania, ar-ticle 9, section 7, provides as follows: "The general assembly shall not authorize any county, city, borough, township or incorporated district to become a stockholder in any company, associa-tion or corporation or to obtain or appro-priate money for or loan its credit to any orporation, association, institution or in-lividual." Under this section the legislatue would have no right to authorize a ity to appropriate money to any corpora-ion or association. ing the same. A RELIEF BOARD.

In this city it is proposed to get round the difficulty in another way A firemen's relief board is to be organized, consisting of two members from each fire company in the city, together with the chief of the fire department, mayor, city treasurer and city controller. Claims for relief will be reported by the members from each company and after being approved by the board, will be presented to councils for passage, as other fire department bills are. It is thought that this can be done without encountering any egal snags.

Next year when the annual approriation ordinance is made up councils may be asked to insert a line in the fire department section of it providing a disability fund equal to the amount that will be received from the state The firemen are confident that all of this can be done. City officials are not

so confident. Treasurer Boland said yesterday that the money will have to go into the general city fund and while he sincerely hoped the firemen will be able to receive the money he was at a loss to see a way by which it can legally be under the opinions on the subject that he has read.
