Mrs. Margaret Healey, of Price street, instituted a suit before Alderman Moses yesterday against Mrs. John W. Jones for rent due her for the month of April. The hearing evolved some interesting facts, pro and con. Mrs. Healey claims that she had allowed her tenants to reside in her house for a month without asking for the rent. When she did ask for it, she was given an order for the amount, \$5, on the West Ridge Coal company. The order proved worthless.

After considerable delay the Joneses left the house but allowed their furnito remain, thus preventing the further renting of the premises.

Mrs. Jones stated that they had cleaned the premises and when she had gone to get the furniture it was gone, she knew not whither. Upon investigation she discovered that Mrs. Healey had sold her household goods to a second hand furniture dealer for two dollars. She was unable to pay the cent due, as she had no income sufficient and was living at her sister's home.

The case was decided against Mrs. Healey and costs placed upon her.






