TRIED ON THE CHARGE OF EMBEZZLEMENT

Case of Tax Collector T. E. Boland, of Dunmore, Is Now On.

WHAT THE DEFENSE WILL SHOW

Allegation Is that Mr. Botand Turned in Taxpayers on the Exoneration List from Whom He Had Collected Philadelphia, presiding. Taxes -- Nearly All Day Taken Up with the Hearing of Testimony for Minor Importance Disposed Of.

The case of ex-Tax Collector T. E. Boland, of Dunmore, charged by Jeremiah McPeck with the embezzlement of \$1,500 of the county's funds, was called for trial before Judge Edwards, in court room No. 2 yesterday morning. John F. Scragg assists the commonwealth in the prosecution of the case. Hon, John P. Kelly and Hon. M. E. McDonald appear for the defense

The allegation against Mr. Boland s that he collected and converted to his own use taxes which were turned in by him on his exoneration list.

A number of witnesses were called who produced receipts showing that they had paid taxes to Mr. Boland for the year 1895, and then County Commissioners' Clerk C. F. Wagner showed from his records that they had been exonerated. The amount alleged to have been collected in this way figures up to about \$15.

The opening for the defense was made by Mr. Kelly just before adjournment He said they proposed to prove that Mr. Holand did not embezzle even the \$15, to which amount the "\$1,500 or upwards" of the indictment has dwindled. He then went on to explain that in the spring of 1896, when Mr. Boland went to the commissioners' office to make a settlement of his duplicate, there was some objection offered to the size of the exoneration list and the commissioners refused to approve it until he had made further effort to educe it. The exoneration list was left in the commissioners' custody, and he proceeded to lessen its amount as directions of the commissioners. Ah during the summer while collecting the 1896 duplicate, he worked on the 1895 exoneration list, and here and there succeeded in collecting a tax that he had for one cause or another recommended for exoneration.

DUPLICATE OVERLOOKED.

In the following December or in January, 1897, he made a settlement with the commissioners and had his exoneration list approved. He had neglected to take his duplicate along, and being anxious for a settlement so that his bondsmen might be released, he attempted, with the aid of his memory only, to check off such items on the exoneration list as he had succeeded in collecting during the summar.

He discovered afterwards, upon consulting his books, that he had neglected to check off some few of the exonerated names, but thinking it of of 1895, he turned in these moneys at the time of his next settlement. BOGART BURGLARS WILL BE TRIED HERE

New Developments in the Big Jewelry Robbery Were Interesting.

EVERYTHING PROBABLY RECOVERED

List from the Chicago Police Contains Descriptions of Articles Which Compare with the Stolen Property. Desk Sergeant Deiter Will Leave This Morning for Harrisburg to Get the Necessary Requisition Papers. How the Arrest Was Worked.

The Bogart burglary, without a doubt the nearest approach to the real thing ever accomplished hereabouts, will resuit in the prosecution in this city of the three widely-known professional crooks, who were arrested in Chicago Friday, and the facts furthermore tend to show that it was from a local source that the capture was directed and brought about.

Yesterday the developments were rapid and decisive. The description of the property re-covered was addressed to Chief of Police Frank Robling.
