New York, Nov. 15.—Wall street has not seen so dull a day in many months. Even the professional traders were almost out of the market, and there was absolutely no outside inquiry or sign of interest in the market.

A large proportion of the day's trading was done at the close of the day, and the stock fell away at one time 24 points, but closed 11/2 above that. The rally was due to a ruling by the treasury department to apply the conventional 10 per cent tariff bill to refined sugars imported from Denmark. Total sales were 170,700 shares.
