Only Twenty-seven Out of Sixty-one Passengers Were Saved.

THE SURVIVORS ARE BROUGHT TO VICTORIA BY THE SCHOONER FA-VORITE-AMONG THE PASSENGERS WAS A PARTY OF SIXTEEN ITAL-IANS WHO WERE CUTFITTED BY PRINCE LUIGI, OF STALY, AND WERE EN ROUTE FOR KLONDIKE.

Victoria, B. C., June 1.—The schooner Lady Jane Grey foundered ninety miles west of Cape Flattery on Sunday, May 22. Only twenty-seven out of sixty-

one passengers were saved. The survivors were brought here by schooner Favorite. They left for Seattle today on the steamer Kings-

Scattle, Wash, June 1.—The Jane Grey sailed from Scattle for Kotzebue soun, May 18, with sixty-two people on board, including the captain and a crew of eight. Among the passengers was a party of sixteen Italians who were outfitted by Prince Luigi, of Italy. They were under charge of Major Ingraham, of this city, who ascended Mount St. Ellas last summer with Prince Luigi.

RUN ON SPAIN'S BANK.

Long Line of Men and Women Aux-

ions to Change Notes for Silver. Madrid, June 1 .- 5 p. m .- The attention of the public today is absorbing in the condition of the Bank of Spain which is considered more serious than any reverse of the war, inasmuch as the impossibility of the bank to help the government means impossibility to continue the war.

The financial outlook of Spain is rather dark. The government has entrusted the Bank of Spain with the negotiations for a loan of 1,000,000 pesetas at four per cent., which sum is to be raised as required. The bank will endeavor to raise the loan at home

Front Quit Work. Philadelphia, June L.-One thousand longshoremen, employed along the Delaware river front, went on a strike today, and temporarily caused serious trouble to shipping interests. The men demand that they be paid time and a half time for night work and double time for work done on Sunday.

There is no demand for an increase of pay for day work, which is about \$2 a day. Edward McHugh, president of the Longshoremen's association, was arrested this afternoon for breach of the peace and inciting to riot. He was making a speech at the time to longshoremen at Walnut street wharf.


