#### Company's View of Its Rights, Probably Correct.

The Scranton Railway company has been permitted to resume its doubletrack laying on South Main avenue. The work was stopped Friday afternoon by Street Commissioner O'Boyle, acting under Mayor Balley's orders, because of the protests of abutting property owners.

According to the opinion of City Solicitor McGinley the Scranton Railway company can lay a double track on South Main avenue. 


