An elderly woman carrying an anxlous face and a Bible is making visitations those days upon ladies in affuent positions in this city. Many of the hostesses are out of town, but the elderly woman is occasionally fortunate in finding them at home. If she car gain an audience she immediately proposes to pray with the benighted house mistress who is, generally speaking, too astonished to demur, even if she happens to entertain objections to that precise method of evangelization. * * * The visitor usually remarks that nowadays most people seem to think the only ones who need praying for are in the slums or among the poorer classes. For her part, her heart aches for the rich ones who are really being neglected. Their minister daren't tell these influential parishioners that they are poor, miserable sinners and that their fine clothes are but as fiithy rags in the sight of the Lord. Their rebukes are all directed to those outside the first circles and these poor women with their empty lives and shrivelled souls go on to eternal death with nobody to teil them that they are doomed. She proposes to make up for this long neglect and in her way to constitute herself a salvation army to the high classes instead of the masses.

Nearly always the hostess finds herself in the vortex of an actual prayer meeting and has a half terrified vision of herself on the anxious seat in an old-fashioned Methodist revival. Not even the hymn singing is omitted and before the "services" close she has had a mixture of sensations difficult to

classify. Occasionally the "evangelist" strikes an impossible house maid who is disposed to argue the matter when the visitor tells her errand. The following conversation took place on the front door of a palatial residence on Clay avenue the other day:

Visitor-Good afternoon. Are you saved from eternal damnation ; Maid (looking mystified) -- "What,

ma'am?" Visitor-"Do you love the Lord? Is your soul saved?"

Maid (in a relieved tone)-"I'm not of the same faith as you, but I think I shall be saved."

Visitor-"Is your mistress saved? Dees she love the Lord?" Maid (rather doubifully)-I'm not


