THIS AND THAT.

Benjamin Gilbert, of North Garfield avenue, is the proud possessor of probably one of the most unique specimens of the fossil that exists in this valley. Mr. Gilbert is employed as a miner in Capouse colliery and while at work a few days ago found his specimen.

He had blasted down some coal and while his laborer was preparing the coal to load it into the car, the specimen tell from its resting place in a large block of coal. It is the exact reproduction in stone of a human foot and part of the foreleg. The foot part is a little less in size than an ordinary sized adult's foot. The leg part extends from the foot about nine inches and is apparently broken off about the middle of the calf of the leg.

According to geologists, if this specimen represents what was once a human leg and foot, the person must have been of an enormous size, as when human fiesh or the plant world fossilizes the size decreases nearly one-third. For instance a tree trunk, which is frequently found in mining, would be reduced to about one-third the actual size by the time of present-day discovery. Mr. Gilbert has had numerous offers for his specimen, but declines to part with it.




