ASSISTANT CHIEF DIES AT A FIRE

J. J. O'MALLEY SUCCUMBED TO HEART FAILURE.

alarm box sounding taps for "fire out," when he was stricken. His fellow firemen ran to his assistance and securing a passing carriage had him conveyed with all haste to Brown's drug store, on the corner of Washington avenue and River street, a block away.

Dr. John T. McGrath happened along just after he was carried into the drug store and did what he could to relieve The stroke, however, was fatal quet was served. A. D. Blackinton and the efforts of the physician proved futile. Ten minutes after reaching the

irug store he breathed his last. He had suffered from heart trouble for some time and yesterday felt that an attack was coming upon him. After supper he decided to consult his physician and was on his way thither when the alarm sounded. He turned from his purpose and hastening to the

scene of the fire superintended the work of the companies. His devotion to duty proved fatal.

The exertion was too much for his assalled constitution and he collapsed. The remains were taken to the family home on Third street by Undertaker Cusick. O'Malley was 32 years of age and a tinsmith by occupation, being employed as a sheet iron worker in the Delaware, Lackawanna and Western shops. He was serving his second term as district engineer, having filled the office for a three-year term under ex-Chief H. F. Ferber, and was a mem-

ber of the Engle Hose company since its organization in 1877. He was also a member of St. Paul's Pioneer corps and was quite as active in the cause of total abstinence as he was in fire department work. Among his associates he was a most popular young man and all who knew him found in him only qualities to be admired.

He is survived by his mother, a brother, P. O'Malley, teller of the Mer-chants' and Mechanics' bank, and a sister, Miss Mary O'Malley. His father was the late select councilman James


