A bill was introduced in the house by Mr. Woodruff, of Philadelphia, to amend the Bullitt bill by prohibiting the collection of political contributions from or by officers or employes in cities of the first class, and providing a penalty of \$1,000 or one year's imprisonment for violation of the proposed act. Whengver there shall be a violation of he act with the knowledge of any city officer or employe it shall be their duty to arrest or endeavor to procure the arrest of the offender and to make a full report to the civil service board. A failure to perform this duty shall be a sufficient cause for dismissal from the service.

#### Timlin's Bill.

A bill was presented by Mr. Timlin, of Lackawaana, to make it a felony, punishable by a fine of \$100 or one year's imprisonment to wilfully and fraudulently take from any loaded mine car the minor's ticket bearing the name , of the mine attached to the car and substituting another ticket upon which appears another name or number for the purpose of defrauding the miner out of the money owing to him for mining coal.

A bill appropriating \$175,000 to the Erie Soldiers' and Sailors' Home was introduced by Mr. Bricker, of Beaver.
