FOUR MEN FIGHT THREE ARE STABBED

BLOODY AFFRAY OCCURRED ON SPRUCE STREET.

Only a Few Steps from Raymond Court, Where Two of the Men Reside-Quarrel Arose from the Refusal of a Loan of Money-One of the Men Is at the Lackawanna Hospital, the Other Three Are Under Arrest-Cutting Done with a Baker's Knife.

An affray occurred on Spruce street last night about 9 o'clock just above the Arlington hotel. Vincent Galvoceni, of Green Ridge, Pedro Lemeni, of Moir court, Frank Josepho and Luigi Gialonardo were the actors. Galvoc ni was wounded in three different places in the face and neck; Lement has three fingers severely cut and a small scratch on the forehead, and Josepho has a forearm midway between the eli-ow and wrist.

Lemeni to loan Galvoceni some money and really started in Cassesse's hook on Lackawanna avenue. They were told to go home and were on their way there when the trouble started. Lemeni claims that Galvoceni cut him and he ran away to keep out of trouble and does not know how the other two got wounded.


