



Every place of business having a nickel-in-the-slot machine on the premises and running in the city last night was visited by the police authorities and orders left that the machines must be removed by today. Moreover, the machines must not be taken back either. Chief of Police Robling, Detective Moir and Mounted Officer Block visited the central city places and the lieutenants of the outlying precincts looked after the suburbs. It is estimated that there are over one hundred such devices for gambling in the city. About midnight a squad in charge of
