THE MARKETS.

Wall Street Review.

New York, June 13.—There was a marked disposition from an early period in the day's trading on the Stock exchange to take profits in many of the various issues. This was evident practically in all other standard stocks and made itself increasingly evident in the industrial specialties. The very decided strength manifested by a small group of the industrial served to attract a sort of cover to the profit taking sales which were fed to the market. The recent strength of Federal bonds was a notable feature during the early hours of the day and other members of the floor group notably Brooklyn Transit and People's Gas were strong in sympathy; and an advance in Metropolitan, Manhattan hotel and Southern in the Wisconsin Central, both old and new. Total sales, \$2,500,000. United States bonded, 1/4 and the 3's, the 4's and the 5's, 1/4 in the closing.

By Carrington & Cusack. New York, June 13.—The market opened strong and active, the steel stocks being the principal feature. The market was tipped for a decline which really materialized and served to check the strength in the balance and the slight Committee houses sold quite freely and traders attacked values on the theory that the rise had been rapid and a reaction was due. Yesterday and today have both shown evidence of selling of long stock and as a result the market has been driven to general tone somewhat. As we have been a day or two in the market, the very decided parties at work and is no market to buy blindly or pyramid in. It is liable to serious fluctuations and an upward tendency and over trading will surely bring losses. The bears are liable to push the market down, and underlying the whole situation is the fact that securities are at a very high price and the market is very weak and take fair profits.
