

There was an active opening in the stock and it was advanced early in the day almost a point. The demand was evi-dently satisfied for the time being and the movement lacked snap. The price was allowed to lag. There were various factors of strength in the day's develop-ments which prevented a break of price of railroad stocks but there was obvious profit taking at some points and the day's net advances were small except in a few cases. The offers were very well taken, and the market was regarded as acting in **a** perfectly natural manner. The Vanderbilt brokers, Standard Oil issues and the Flower crowd were all moedrate buyers at the advance. Some of the Brooklyn recently sold was taken back and there seemed to be consider-able increase in commission business. Crop reports were favorable and the news from the labor centers was con-sidered of a conciliatory character. 
