COLLISION.

Street Car Runs Into a Dray and Kills a Horse on Belmont Street.

Yesterday morning shortly before it o'clock Drayman William Bell was about to unload a barrel of oil at the store of Merchan; Rigo, a short distance this side of the Ontario and Western crossing, on Belmont street. The street car track is on one side of street and it was necessary to leave the front end of the wagon and horse on the ralls.

Motorman White descended the hill at a fair rate of speed and when Mr. Bell heard the car coming he jumped on the wagon to drive up and let it pass. Contrary to expectations it did not stop and the next instant he jumped to save his life. The car ploughed through the wagon and hurled the team into the gutter, running nearly forty feet beyond the point of impact before stopping.

One horse was so badly injured that it had to be shot and the other was cut The vehicle was demolished some. and the car was slightly damaged. The cause of the accident is attributed to wet rails.

a Coroner's Jury. Last Monday the employes of the




