We find that Margaret Reiber, daughter of Mr. and Mrs. Peter Reiber, of Grace street, Scranton, died on Friday, August 25, 1899, of starvation, due to the fact that the child did not have proper medical attention. The parents are be-lievers in the Christian Alliance doctrine with reference to the treatment of dia-

We consure the parents for their neg-ect of the child, which from the evidence before us, we believe was the cause of the death of Marguret Reiber.


Mayor Wants City Property.



sustained him in his claim of prerogative in the removal of subordinate oficials, including the police force, and elect council was compelled to abanon its fight to rule in this matter. The same contention as to jurisdiction rose in the other cities.
