Met a Number of Persons from This Region and Had a Very Enjoyable Trip-Was in Paris When the Dreyfus Verdict Was Announced. No Great Furore Such as One Would Imagine from Reading the American Papers-Chummed with Dr.

Hoban, bishop of Scranton, returned home at 5:35 p, m. yesterday from his summer vacation in Eu-He arrived on the Bremen steamer Barbarosa, yesterday merning and upon learning of the death of Rev John Loughran came home direct. Pils boat passed the Olympia in the lower harbor during the night, but was not aware of it until anchor was dropped off Staten Island in the morning

He was much benefited in health by his trip and reports having bad a most enjoyable time. His main purpose in going abroad was to perfect himself in German, which language ! one of the seven in which he son preach without previous preparation. He spent nearly all of his time traveling through the German empire and availed himself of every opportunity of ecoming acquainted with German as the Germans "Spracken" it.

BELIEVE HIM GUILTY. The great bulk of the French people believe Dreyfus guilty, the bishop concludes from his observations. No particular class, outside of those who father the thought with the wish, can s raid to make up this majority. As an instance of this the bishop told of "League of Justice" composed er tirely of Catholics and formed for the sole purpose of aiding Dreyfus to prove
