Mayor and Other City Officials Visited the Underground Den Yesterday and Decided That Something Must Be Done at Once—Mrs. Barrow-cliff Sustained a Stroke of Paralysis While Out Driving—Marriage of Miss Caroline Davies and John Evans—Personal Notes.

After many years of talk and discussion, there is at last a prospect of a new station house, or, at the least, a remodeling of the old one in North Scranton.

Mayor Moir yesterday, in company with Chairman Keller, of common council, Select Councilman Finlay Ross and Chief of Police Robling, made an inspection with a view to remedying the existing evils.

The place, which is in a cellar below the hose house occupied by the Liberty and Niagara Hose companies, was found to be in its usual horridly unsanitary condition. All decided that it was no place to imprison any human being.

Three possible plans of relieving the difficulty are suggested by the mayor. The first is the renting of the station house in the best sanitary condition; the second, renting of another cellar or small store and fitting it up for station purposes; third, remove one of the companies from the hose house to some other section of North Scranton now renting better fire protection and fitting up the room made vacant as a combination station house and police court room. It is thought that this could be done for about \$500.

The mayor will in all probability recommend either one of the above plans to the consideration of council at their next meeting.


