Verdict in Smith-Loomis Case.

The jury in the case of J. S. Smith, Mrs. Cornelius Smith and Joseph Fellows against F. E. Loomis and John H. Fellows returned a verdict Saturday in which they award the plaintiff the sum of \$2,938.04. This is practically a victory for the defense, as the finding is in accordance with the statement of the account as filed by the defendants.




