Altogether the total supplies of the army amount to 215,025 pounds a day, 1,464,000 pounds for ten days and 4,329,000 pounds for the total of thirty days. For a year this makes being made for 50,000 troops, and by a grand total of \$1,484,125 pounds, or about 40,000 tons.


