CRIME IN THIS COUNTY.

Figures Taken From the Records in the Office of Clerk of the Courts T. P. Daniels.

The annual report of criminal statisties which is yearly submitted to the state board of charities and corrections has just been prepared by Clerk of ficent bouquet of bridal roses and lilies the Courts Daniels. The report is for the five sessions of court ending with the June, 1899, sessions and gives the number of persons charged with crime and the disposition made of the cases The following is the detailed table

crime is just seventy-eight less than for the previous year. Of the 1827 cases brought before the grand jury only 544 true bills were found, or only 29 per cent. Of the 741 persons tried only 154 convictions were secured, or about 20 per cent,

There are fifty-nine different crimes included in the list. Of these, assault and battery, of course, leads, over 40 per cent of the cases being listed under this head. Larceny ranks second and then comes tippling houses, robbery, malicious mischief, false pretenses, robbery and burglary in the order named. There were five murder cases.
