AMENDMENT TO THE CONSTITUTION PROPOSED TO THE CITIZENS OF THIS COMMONWEALTH FOR THEIR APPROVAL OR REJECTION BY THE GENERAL ASSEMBLY OF THE COMMONWEALTH OF PENNSYLVANIA, PUBLISHED BY ORDER OF THE SECRETARY OF THE COMMONWEALTH, IN PURSUANCE OF ARTICLE XVIII OF THE CONSTITUTION.

A JOINT RESOLUTION Proposing an amendment to the Constitution of the Commonwealth.

Section 1. Be it resolved by the Senate and House of Representatives of the Commonwealth in General assembly met. That the following is proposed as amendments to the Constitution of the Commonwealth of Pennsylvania, in accord-

Amendment One to Article Eight, Section One.

Add at the end of the first paragraph of said section, after the words "shall be entitled to vote at all elections," the words "entitled to vote at all elections," the words "entitled however to such laws requiring and regulating the registration of electors as the General Assembly may enact," so that the said metion shall read Section 1. Qualifications of Electors. male citizen twenty-one years of age, possessing the following qualifications, shall be entitled to yote at all elections, subject however to such

He shall have been a citizen of the United States at least one month.

He shall have resided in the state one year for if, having previously been a qualified elector or native born citizen of the state, he shall have removed therefrom and returned, within aix months, immediately preceding the deaix months, immediately preceding the elec-

He shall have resided in the election district where he shall offer to vote at least two months immediately preceding the election.

If twenty-two years of ago and upwards, he shall have paid within two years a state or county tax, which shall have been assessed at least two months and paid at least one month before the election.

Strike out from said section the words 'but no elector shall be deprived of the privilege of voting by reason of his name not being registered,' and add to said section the following words. 'but laws regulating and requiring the registration of electors may be enacted to apply to cities only, provided that such laws be uniform for cities of the same class,' so that the said section shall read as follows:
