NO CAR'S RUNNING.

Citizens Censure City Authorities
for Not Revoking Franchises of
Scranton Railway Company.

The striking conductors and men of the Carbondale division have opened headquarters in the Academy of Music building, on South Main street. But one car went through this city since the morning the strike was declared. The car was run on Saturday, Master Mechanic Mullen being the motorman. The car had a section gang on, who were taken here to clear the tracks. No obstructions of any kind were found.

A report gained credence last night that two cars would be in waiting for passengers at the corner of Salem avenue and Main street after the show. However, no cars were in evidence when the crowd came from the theater. Prominent men have called at the strike headquarters, asking them to ask the city authorities to revoke the franchises here unless cars are run on stipulated time. A number have stated that the ordinance had a provision in it to the effect that the franchise of the company should be revoked unless the cars were run on the streets daily. Many severely censured the city authorities for not taking some action on the matter.

The Tribune correspondent called upon Mayor Kilpatrick and was advised by him to read the ordinance. The original copy of the ordinance, File No. 26, was seen in City Solicitor Stuart's office. There is no reference in the various stipulations of the ordinance calling for the running of cars, neither daily nor monthly. The ordinance was made out to the Carbondale date Traction company, passed select council Feb. 24, 1892; common council, March 7, 1892, and was approved by Mayor C. E. Reetew, on March 8, 1892. During Mayor J. W. Kilpatrick's term, a second ordinance was granted to the Scranton Railway company, but the terms of the first ordinance were repeated. The only changes were in allowing the company to narrow the track.
