

After the invention of paper the manufacture of cards became extensive, but declined somewhat when card playing was forbidden by several of the German States and by the English government on account of the supposed immoral tendency. Before the era of paper, cards in the Orient were made of ivory, papyrus and canvas, less fre-


One of Southard's decisions displeased Centerfielder Duffy, of Albany, and he rushed up to the umpire and






